I refer to my appointment together with Simon Cathro as Joint and Several Receivers and Managers of GSI on 3 September 2013. I am writing to you because you are recorded in GSI's books and records as holding notes issued by GSI.

An extract from GSI's books and records has now been obtained with your account details. Account balance information is provided at 9am on 19 July 2013, when GSI implemented a voluntary suspension of note holder accounts.

The attached form may also be used to amend your postal address details if required.

The next steps in the Receivership are:

- ▶ Note holder information sessions are being scheduled to be held in early October 2013 and I will write to you shortly to confirm these details
- ▶ A detailed report to note holders is being prepared and will be provided to you in advance of the information sessions

Due to an issue in the way that GSI's records have been structured you will receive a separate statement for each of your accounts. Accordingly, if you hold multiple accounts with GSI you will receive multiple statements.
